Additionally, a successful submission must incorporate a **twist ending**. The surprise may be dark, humorous, ironic, or thought-provoking, but it should transform the reader's understanding of the story.

Authors are encouraged to explore present-day themes and conflicts (technological, environmental, cultural, and economic) while staying rooted in the timeless spirit of the chosen tale.

Word count is 5,000 maximum. All fiction genres welcome. Rhymed prose will be considered. Must be a TVWI member at any level (Basic, Associate, Professional).

Anticipated timeline includes story selection by February 2026 and publication in July 2026.

SUBMISSIONS

All submissions are considered final. No editing or revision is allowed after work is submitted. Submissions will be judged by a jury for inclusion in the anthology. Not all submissions may be published. Final proofreading/copy editing will be done by TVWI before publication

Please submit only original, previously unpublished work as .doc/docx/rtf by December 7, 2025. One submission per writer. No simultaneous submissions. No AI generated work. Preferred formatting 12pt. Times New Roman, double spaced, with numbered pages. Submit via email to Submissions@TemeculaValleyWI.com with subject line "TVWI Anthology" + Story Title + Author Name.

Body of the email should include: the name of the chosen tale you retold; from which collection it was drawn; story word count; your name; pen name (if applicable); and a 150-word max bio.
